#### COVID-19: Some EU Green Deal initiatives to be delayed

It has always been a matter of time for this news to arrive. So, as expected, the European Commission is reviewing its 2020 work programme in light of the Corona crisis and to prioritise related and more pressing files. A leaked list of delayed initiatives shows that some climate policies considered as key remain on track. It is for instance the case of the Renewed Sustainable Finance Strategy, the 2030 Climate Target Plan, and the building Renovation Wave, all expected in Q3 2020. Among those which might face a delay we find the Strategy for Smart Sector Integration initially expected in Q2 2020, the European Climate Pact expected in Q3 2020, and the Strategy for Sustainable and Smart Mobility expected in Q4 2020. An updated work programme will be published on 29 April.

## VIP of the month: Virginijus Sinkevičius

Pronounceability of names is not getting easier here but let's focus on important things. The Lithuanian Commissioner is famous for a rarer characteristic to be found within the college of Commis-

sioners: he is only 29 years old but has already served as Minister of the Economy and Innovation in his country. He is from the generation that "For us 2050 is not just a target on a piece of paper, we have to live it". Now he has the role of preserving and protecting Europe's seas and oceans, its landscapes and natural environment. "We only have one Planet Earth, and yet by 2050 we will be consuming as if we had three," said Environment, Oceans and Fisheries Commissioner Virginijus Sinkevičius when presenting the new EU Circular Economy Action Plan. Seeing the amount of legislation outlined by his Action Plan and the profound changes in consumption habits it requires (35 pieces of legislation to be precise - changes -of-habit are uncountable) we can tell that he has a lot of time ahead before retirement, fresh energy and bold ambitions.

March, the Commission held a <u>workshop</u> for preliminary discussions with stakeholders. The strategic plan, which will outline the EC's politically supported proposal, is expected to be published in **May 2020**. During the workshop the EC presented an overview on what are the objectives of the strategic plan and what it should include. The need for reducing methane emissions was explicitly identified by the European Green Deal, because of its potential positive contribution to the Paris Agreement objective, and it would be the first time the Commission addresses companies for reducing methane emissions in the perspective of climate change. So far the intention is that the "methane strategy" should have (1) a strong international pillar and address both European and international issues, (2) follow a holistic approach and look at all sources and at the entire value chain, (3) tackle the lack of reliable information on measuring, quantification, reporting and verification of methane emissions.

## **EU Green Deal: Circular Economy Action Plan**

On **11 March** the European Commission published the <u>new EU Circular Economy Action Plan</u>. The Action Plan, one of the main blocks of the European Green Deal, aims to deliver measures



across the entire life cycle of products, from design and manufacturing, to consumption, repair, reuse and recycle, in order to ensure that resources are kept in the EU economy as long as possible. The new Circular Economy Action Plan can be divided in 4 key areas: (1) a sustainable product policy framework to streamline sustain-

ability and promote circularity in the production processes, ensuring products last in the market longer and their value chain is more traceable; (2) a set of requirements for companies to provide additional information about products to empower consumers and public buyers; (3) more requirements on companies to increase the use of recycled materials and decrease waste; (4) the promotion of the Circular Economy at international level. The EC aims to <u>focus</u> on those sectors that use most resources and where the potential for circularity is high such as electronics and ICT, batteries and vehicles, packaging, plastics, textiles, construction and buildings, food, water and nutrients. Some of the 35 legislative initiatives expected under the Circular Economy might indirectly impact the activities of energy utilities, notably where it concerns rules around waste incineration and the reuse and recycle of primary and raw materials.
