METAPV SMART GRID PROJECT: TOWARDS AN EFFICIENT SOLUTION FOR HIGHER PV INTEGRATION

On **24 March**, an all-day event, co-organized by CEDEC, brought together energy experts, policy makers and representatives of the European institutions. The debate allowed participants to find out how distribution

grid hosting capacity can be increased at a fraction of the cost of traditional grid reinforcement and to discover the lessons learned from controlling PV plants in real, historically grown distribution grids

EUROPEAN PARLIAMENT & EUROPEAN COUNCIL: ENERGY UNION

An [exchange of views](#) between the European Parliament (ITRE) and the Commission Vice-President for Energy Union, Mr Marcos Sefcovic, was held on **23 March** on the next steps in the implementation of the Energy Union Strategy.

Heads of State and government adopted European Council conclusions

on the Energy Union on **19 March** 2015. During the discussions, leaders focused in particular on energy security issues. The [conclusions](#) express support for the creation of the Energy Union, for increased market integration through inter-connections as well as more transparency in gas contracts.

EUROPEAN COMMISSION : CITIZEN'S ENERGY FORUM (LONDON)

The European Commission and CEER organized on **12 & 13 March** the Citizen's Energy Forum in London. CEDEC actively contributed to the High-level opening panel "Consumer's central role in energy Markets", and

to the following debates. The initiatives of local actors – cities and local utilities – got more attention than ever before, in line with the recent CEDEC position paper on the Energy Union.

CEER PUBLICATION: ADVICE ON DATA MANAGEMENT FOR BETTER RETAIL MARKET FUNCTIONING

CEER has published on **19 March** its [Advice on Data Management for Better Retail Market Functioning](#). This document outlines guiding principles to form a basis for energy customer data
