### **EUROPEAN PARLIAMENT: SMART GRIDS**

Mrs Ulvskog (S&D) has presented, on 26 September her draft opinion on local and regional consequences of the development of smart grids. She notes that the proper integration distributed of renewable generation will be unfeasible without the development of local and regional smart distribution network grids for electricity.

She also calls for cooperation in the development of smart grids at European, national and regional

level and she also notes that further cooperation between the energy and the information and communications technology (ICT) sectors must be encouraged.

She calls on the Commission to assess whether it is necessary to bring forward proposals, in line with the third internal energy market package, for the development and promotion of smart grids.

# EUROPEAN PARLIAMENT: 2030 FRAMEWORK FOR CLIMATE AND ENERGY POLICIES

The <u>own-initiative report</u> on the European Commission's Green Paper on 2030 framework for climate and energy policies will be drawn up jointly by the corapporteurs MEP's Mr Szymansky (ITRE) and Mrs Delvaux (ENVI).

The new framework should draw on the experience from the current policies and take into account ongoing developments within the EU. A first exchange of views, on 26 September 2013, provided the rapporteurs with the opinions from other members. The next meeting is foreseen on 7 November 2013.

Deadline for amendments: 12 November 2013.

# EUROPEAN PARLIAMENT: INVESTMENT PROJECTS IN ENERGY INFRASTRUCTURE WITHIN THE EU

The ITRE Committee has voted, on 26 September, on Ms Valean's report on a proposed regulation to establish a common framework

for the notification to the Commission of data and information on investment projects in energy infrastructure in the electricity and the gas sectors. Members tabled a total of 82 amendments proposing minor adjustments to the Commission text.

The vote in plenary session at the European Parliament is expected on 9 December 2013.

#### **EUROPEAN PARLIAMENT - CONCESSIONS DIRECTIVE**

On 5 September, the proposal for a directive on the award of concessions as agreed between the Council and the Parliament during trialogue negociations was adopted. The rapporteur, Philippe Juvin, expressed his satisfaction that a global political agreement was reached.

The Directive will now be put to a vote in plenary - foreseen on 9 December 2013 - together with the public procurement directives.
