COMMISSIONER CAÑETE PRESENTS CONSULTATIVE COMMUNICATION AT THE ITRE COMMITTEE

On 22 September, Arias-Cañete, Commissioner for Climate Action and Energy, presented before the ITRE Committee in the European Parliament the EC's consultative Communication, launched on 15 July 2015. The deadline for the consultation is 8 October. The public consultation

focuses on a new energy market design, in view of preparing legislative proposals in 2016. The aim of the Communication is to give the opportunity to all stakeholders to provide feedback on the vision presented and the identified steps required to deliver that vision.

THE VLERICK ENERGY CENTRE LAUNCHES FINAL REPORT ON THE EUROPEAN DSO LANDSCAPE 2020

The Vlerick Energy Centre presented the results of a web-based survey on the future of DSOs in Europe's energy sector. The final report, also supported by CEDEC, encompasses changes in the DSO environment, strategy, role, ownership and regulatory framework.

EUROPEAN COMMISSION FORA: FLORENCE & MADRID

A high-level conference on a new energy market design will take place on 8 October in Florence, followed by the Electricity Forum the day after.

Topics to be covered during the conference will include: how energy markets can support the flexibility challenge and meet consumer needs; delivering a secure system; and fostering better integration in energy markets across Europe. Agenda

The Madrid Forum will be held on 14-15 October and will address the cross-border trade of gas, in particular the tarification of cross-border gas exchanges, the allocation and management of scarce interconnection capacity and other technical and commercial barriers to the creation of a fully operational internal gas market.

NETWORK CODES - Electricity

New steps have been taken in the development of European legislation regarding the network codes. You can find an overview of the current situation HERE.

In order to guide the implementation of the network codes in the Member States, a first European Stakeholder Committee (for the Market codes) has been set up, in which CEDEC will actively participate.

It is important that the experiences and questions from the National/regional implementations are fed back to the NC-process at EU-level, to ensure that the Network Codes/Guidelines are interpreted consistently and to prevent as much as possible diverging implementations.
